The pizza will be served by certain parents of the students of the School.

The pizza delivery shall commence on Monday, October 2, 2017. All orders must be submitted by Thursday, September 28, 2017.

The gluten free pizza will be provided by Phil's Pizza, located in Montvale, NJ. Phil's Pizza has represented to the School and USRPTO that it will use its best efforts to make sure that the pizza that is made will be gluten free (and shall be openly labeled as such).

By signing below, the parent or legal guardian hereby understands that despite the best efforts of the pizzeria, School and USRPTO, there is an inherent risk of cross-contamination* either at the time the pizza is made or at the time the pizza is served. By signing below, the parent or legal guardian is assuming and acknowledging such risk. By signing below, the parent or legal guardian hereby releases and will hold harmless the pizzeria, School and USRPTO, as well as its officers, directors, employees, agents, licensors and suppliers (including parents who serve this lunch), from and against all losses, expenses, damages, injuries and costs, including reasonable attorney's fees, in the unlikely event gluten is found in the pizza and/or as a result of any cross-contamination.

Cross contamination can be transferred to food by hands, food-contact surfaces, sponges, cloth towels and utensils.
